

## TENDER NOTICE

- i. Sealed Tenders based on items rates are hereby invited for the works mentioned below from the contractors / firms enlisted / renewed with C&W Department / Pakistan Engineering Council (under CODE CE10) duly attested from the competent officer GIS Manager, GIS LAB Punjab Forest Department 108 Ravi Road Lahore for year 2022-23.
- ii. Tender documents can be obtained immediately after date of publication from the undersigned against written request accompanied with attested copies of enlistment up to date renewal letter and free receipt Pakistan Engineering Council license, authority letter on letter Pad of contractor / firm identity card of contractor / managing partner of the firm along with registered power of attorney, earnest money in shape of deposit at call from any scheduled bank and on payment of prescribed tender fee in the form of CDR / bank draft / cashier cheque of any scheduled bank in favor of the GIS Manager, GIS LAB Punjab Forest Department 108 Ravi Road Lahore
- iii. Tender rates and amounts should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents. No rebate on tender's rates will be acceptable.
- iv. Tenders will be issued and received in the office of the undersigned till 08-02-2023 at 05:00 PM and will be opened on 09-02-2023 at 12:00 PM by the tendering committee in the presence of intending contractors or their authorized representatives. It is also mentioned here that any person can come and watch / witness the tender opening proceedings. Press reporters and elected representatives are also particularly encouraged to attend and witness the tender opening procedure.
- v. Conditional tenders and tenders not accompanied with earnest money at 2 % on the total estimated cost in shape of deposit at call issued from any scheduled bank in favor of GIS Manager, GIS LAB Punjab Forest Department 108 Ravi Road Lahore.
- vi. In case of tender amount being less than 5% of estimated amount, the lowest bidder will have to deposit additional performance security in shape of deposit at call from any scheduled bank. Equal to the amount difference between estimated and quoted amount within 15 days otherwise it will be rejected.
- vii. The procuring agency reserves the rights to reject all applications / tenders before issuance of acceptance letter. However, the authority will communicate the ground for rejection of any application on request of applicant but is not required to justify those grounds.
- viii. All the PPRA rules 2014 will be followed during tender opening procedure.
- ix. Tenders will be issued / provided to the contractor soon after publishing / advertising, the tender detail can receive from office of under signed.


**NOTE:** Tender will be issued only to those who will fulfill the following criteria:-
